## BUILDING PERMIT APPLICATION INFORMATION

Before any Town of Flambeau building permits can be issued you must first contact the Rusk County Zoning Administrator at 715-532-2156 or at [RuskCounty.org](http://RuskCounty.org).

You must provide a copy of your County permits to the Town Clerk when you apply for a Town of Flambeau Building permit. The Town Clerk for the Town of Flambeau is identified on this letterhead.

Permits shall be obtained prior to any construction, and before any manufactured home or mobile home enters the Town of Flambeau.

### FEES

Any building over \$5,000.	\$20.00
----------------------------	---------

Any structure valued at less than \$5,000.00, without electrical service or plumbing is exempt from obtaining a building permit.

Permits shall expire 24 months after the date of issuance. If the building or structure is not completed within this 24 month period, a new building permit must be obtained.

The penalty for non-compliance with this ordinance is a fine of \$50.00, and an additional \$20.00 per day for each day that the non-compliance continues.
